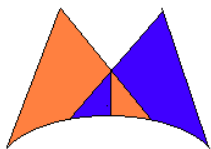

Gist of the proceedings of the 21st Annual General Meeting (Post-IPO) of Rama Telecom Limited

A. Date, time and venue of the Annual General Meeting:

The 21st Annual General Meeting (Post-IPO) of the Company (Meeting) was held on Tuesday, September 30, 2025 through Video Conferencing (VC) / Other Audio-Visual Means (OAVM). The Meeting commenced at 11:00 a.m. (IST) and concluded at 11:35 a.m. (IST).

B. Proceedings in brief:

- Mr. Rama Kant Lakhotia, Chairman, chaired the Meeting.
- The Chairman informed that the Meeting was held through VC / OAVM in compliance with the circulars issued by the Ministry of Corporate Affairs, applicable provisions of the Companies Act, 2013 and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.
- The requisite quorum being present, the Chairman called the Meeting to order.
- The Chairman addressed the members. A copy of the Chairman's Statement, filed with the stock exchanges, is also available on the website of the Company.
- The Chairman informed that remote e-voting commenced at 9:00 a.m. (IST) on Saturday, September 27, 2025 and concluded at 5:00 p.m. (IST) on Monday, September 29, 2025.
- The Chairman also informed the members that Mr. Anil Kumar Dubey, from M/s M & A Associates, Practising Company Secretary, was appointed as the Scrutiniser to scrutinise the voting through electronic means (i.e. remote e-voting and voting at the Meeting through electronic voting system).

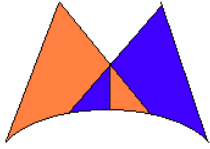
C. Resolutions contained in the Notice dated September 8, 2025
